The Wauzeka Steuben School District will receive sealed bids via the online electronic bid service through QuestCDN VBid online bidding or by sealed paper copy. Sealed paper bids shall be delivered to the TEAM Engineering, Inc., 210 Guard Street, Wauzeka, WI 53826 for the 5339-00-74, V Wauzeka, LED Crosswalk Signs, Station Street Intersection project by April 21, 2025, at 10:00 a.m., C.S.T. Both electronic and paper bids will be publicly opened and read aloud at that time.

The project shall supply and install solar rectangular rapid flashing beacons and solar advance warning devices for the Station Street Intersection crosswalk. The work under this contract shall consist of solar crosswalk devices, advance warning, signage, restoration, traffic control, and all incidental items necessary to complete the work as shown on the plans and included in the proposal and contract.

Bid Consideration

No bid shall be considered unless accompanied by the Proposal Agreement fully executed by the bidder. The bidder that is awarded the contract agrees to execute the contract agreement, payment bond, and performance bond within fifteen (15) days after the Notice of Award, begin work no later than ten (10) days after written Notice to Proceed, and complete all work included under the terms of the contract in the allotted time.

No proposal will be accepted unless accompanied by a certified check or bid bond equal to at least five percent (5%) of the amount bid, payable to the OWNER as a guarantee that, if the bid is accepted, the Bidder will execute and file the proper contract and bond within 15 days after the award of the contract. The certified check or bid bond will be returned to the Bidder as soon as the contract is signed. If after 15 days the Bidder shall fail to do so, the certified check or bid bond shall be forfeited to the OWNER as liquidated damages. BIDDER is required to deliver the original certified check or bid bond within 48 hours of bid opening to Wauzeka Steuben School District . 301 E Main Street, Wauzeka, WI 53826. Bids may not be withdrawn within 60 days after the date of the bid opening.

The OWNER reserves the right to increase or decrease the quantity of any item or portion of the work, or to omit portions of the work, as may be deemed necessary by the OWNER, and the same shall in no way affect or void the contract, except those additions to, or deductions from, the contract price will be appropriately made. The OWNER reserves the right to waive any informalities, or to reject any or all bids, or any part of a bid, and to award the Contract to the Bidder, who in the judgment of the OWNER, will best serve the interest of the OWNER. Bid security will be retained if the Bidder is awarded the work and fails to execute the Agreement and furnish Performance and Payment Bonds.

The letting of the work described herein is subject to the provisions of Sections 66.29 and 66.293, Wisconsin Statutes.
